E19 had spent much of his childhood in local authority care. As E19's childhood journey progressed he presented with a complex care history often characterised by placement disruption. E19's needs became more complex which resulted in several unplanned placement moves.

There were a number of incidents of over a one year period of time self- harm, missing from home and placement breakdown which prompted the need for a local children's safeguarding practice review to be carried out.

### The review

The review identified key themes to be reviewed. These were: Partnership commissioning for children -organisational barriers to commissioning placements, responsibilities of commissioning. Placement Planning & Breakdown Management effectiveness of processes, escalation to avoid crisis breakdown Provision of services for children and young people with complex needs across the partnership. Use and availability of therapeutic provision in residential placements for children and staff. Shared Understanding of Tier 4 Mental health provision.
