K21 was 16 years old and had been involved in an incident in a public place in which he suffered near miss fatal injury. The persons involved knew each other and K21 expressed that he did not wish to pursue involvement with Greater Manchester Police.

## The review

The review looked at: Recognition and response to criminal exploitation from agencies Effectiveness of interventions by multi agency teams Similarities between this review and others involving young people where complex safeguarding issues have been a feature in their lives. ## Recommendations

- Establishment of a Local Steering Group to support the GM Trauma Responsive and ACE Framework Implementation Plan proposed by the Greater Manchester Combined Authority.
- Determine whether Tameside's existing complex safeguarding offer is sufficient in regards to issues being identified by research into this area of practice.
- Provide assurance that the 'Local Learning Points' listed in Chapter 16 of the National Panel's report 'It was hard to escape' have been progressed or that there is a plan in place to do so locally.
- Complete consultation with the children's workforce regarding their knowledge, understanding and application of practice relating to Tameside's complex safeguarding offer.
- Partner agencies utilise the Early Help Assessment and Team Around the School approach at the earliest opportunity when responding to signs of exploitation.
- TSCP to host a Practitioner Forum on the topic 'developing trusted relationships' so that professionals can share good practice and develop alternative ways to engage families.
- Review recommendations from this review in line with recommendations made for other young people who may be at risk of harm from complex safeguarding issues.

## The findings

Young people who are involved in criminal behaviours are not always viewed by practitioners as a child in need of care and support. Assessment of complex safeguarding issues can fall out with traditional child protection policy and procedure which makes recognition and response to 11/11 child abuse and application of thresholds difficult for practitioners to help and support families. The use of a trauma informed approach to multi agency service delivery would enhance the response 111111 to young people who are affected by complex safeguarding issues.
