Over the last 3 years, ten case reviews have been completed within Tameside. This briefing gives common themes across the learning from these ten cases to ensure practice improvements from these reviews.

The findings

The findings are based on what professionals can improve on, which reduce the risk of the same themes happening again

In 60% of case reviews, issues around communication between

agencies was identified as problematic, such as lack of sharing information, delays in sharing information and lack of joined up thinkina.

In half of the cases, a lack of professional curiosity was identified as

a factor in the case.

In 50% of case reviews during the operational period investigated it, was discovered there was challenge between agencies, but escalation

procedures were not used.

In four cases there was a lack of understanding of TSCP

arrangements, such as use of the escalation policy, and an awareness of Greater Manchester Procedures

Safeguarding concerns

Three themes emerged in the last ten case reviews; Non-accidental injury (4 reviews), sexual harmful behaviour (2 reviews) and selfharm (2 reviews). The other 2 case reviews had In five out of the ten cases, the child had been identified with either a mental health condition or diagnosed with a mental health condition. The toxic trio was a common theme in the cases reviews; parental mental health (6 reviews), substance misuse (6 reviews), and domestic Abuse (5 reviews).
