Notice is hereby given that Tameside Metropolitan Borough Council has designated a group representing the local community in the Denton South Area as the Denton South Neighbourhood Forum pursuant to section 61F of The Town and Country Planning Act 1990.

Notice is also hereby given that Tameside Metropolitan Borough Council has designated the neighbourhood area as applied for by Denton South Neighbourhood Forum as the Denton South Neighbourhood Area pursuant to section 61G of The Town and Country Planning Act 1990. The boundary of the designated area is shown on the attached map.

Reasons for the decision(s):

- (i) The application submitted is valid
- (ii) The application to be designated as a neighbourhood forum meets the requirements of section 61F(5) and 61F(7) of the Town and Country Planning Act 1990
- (iii) The application to designate the neighbourhood area meets the requirements of Section 61G of The Town and Country Planning Act 1990
- (iv) In all other aspects the applications meet the criteria established in The Town and Country Planning Act 1990, The Localism Act 2011 and The Neighbourhood Planning (General) Regulations 2012
- (v) In accordance with section 61F(8) of the Town and Country Planning Act 1990 the designation of the Denton South Neighbourhood Forum will cease to have effect at the end of the period of 5 years from the date of designation.
