#### **PEN Conference**

Wednesday 15th February 2023

We are excited to invite you to our first evening Partnership Engagement Network Conference. It is an excellent opportunity for you to hear about and have your say on health and other important topics relating to Tameside.

The next PEN Conference will be held on **Wednesday 15th February, 6:30pm-8:30pm and will be held virtually**.

We will discuss two topics:

- Greater Manchester Elective Care Services: In Greater Manchester there are
  approximately 535,000 people waiting for planned hospital care, also known as
  elective care. NHS organisations across the region are working together to reduce
  the backlogs and get people seen and treated as soon as possible. We will ask for
  your thoughts and input on how we can best support people while they wait.
- Tameside Council's Engagement Strategy: In July 2022, we conducted a public consultation on our approach to engaging with the public asking you how we currently do and how we could improve. We have listened to your feedback and have drafted our Engagement Strategy for 2023-2027. We would like to present the helpful feedback we received and hear your views on the objectives we developed based on this feedback.

#### National

 \*NEW\* Employment: Draft Code of Practice on Dismissal and Re-Engagement

Deadline: 18/04/23

This consultation from the Department for Business, Energy, and Industrial Strategy is seeking views on the draft Code of Practice on dismissal and re-engagement.

The Code sets out employers' responsibilities when seeking to change employment terms and conditions, if there is the prospect of dismissal and re-engagement. It requires employers to consult staff and explore alternative options, without using the threat of dismissal to pressure employees to agree new terms.

This is an opportunity for all interested individuals and groups to review the draft Code, consider its provisions and provide their views on it. The consultation will remain open for twelve weeks. The Government will analyse all submissions, and take the views expressed into account before publishing a response and final version of the Code in due course.

\*NEW\* Charities: Use of Social Media

Deadline: 14/03/23

The Charity Commission are consulting on draft guidance for charities on their use of social media.

Their casework suggests that some trustees have limited oversight of their charities' use of social media compared to other aspects of their communication and engagement strategy. This might be due to a lack of confidence or understanding, or because uptake of social media has developed through staff or volunteers.

It is important that there is an appropriate shared understanding of the charity's use of social media and the particular risks it can bring.

The aim of this guidance is to help trustees improve this understanding, and to encourage charities to adopt a policy on social media as a way to set their charity's approach.







The Commission would like feedback during the consultation period on how the guidance currently stands and how it can be improved.

The guidance is relevant to charities in England and Wales, whether or not they are registered with the Charity Commission for England and Wales.

 Introducing further advertising restrictions on TV and online for products high in fat, salt or sugar: secondary legislation

Deadline: 31/03/23

In response to previous consultations (an <u>initial consultation in 2019</u> and a <u>second consultation in 2020</u>), government published a <u>formal consultation response</u> on advertising restrictions for high in fat, salt or sugar (HFSS) products.

This response announced the UK wide policy will:

- introduce simultaneously a 9pm TV watershed for HFSS products and a restriction of paid-for HFSS advertising online
- include all on-demand programme services (ODPS) under the jurisdiction of the UK, and therefore regulated by Ofcom, in the TV watershed for HFSS advertising
- include non-UK regulated ODPS in the restriction of paid-for HFSS advertising online because they are outside UK jurisdiction

As outlined in the consultation response, certain elements of the policy will be taken forward in secondary legislation. These regulations will be made under new powers in the Communications Act 2003, which was amended by the Health and Care Act 2022.

Government is now seeking feedback on our draft regulations from those with an interest in these regulations and who will have to comply with them. The aim of this consultation is to gather views on the specific text in the regulations to ensure these are fit for purpose.

 Levelling Up and Regeneration Bill: Reforms to National Planning Policy Deadline: 02/03/23

This consultation seeks views on the Government's proposed approach to updating to the National Planning Policy Framework. They are also seeking views on their proposed approach to preparing National Development Management Policies, how they might develop policy to support levelling up, and how national planning policy is currently accessed by users.

The UK Government wants to make the UK the best place for veterans to live by 2028. Change has already started. For the first time, the Census counted UK Armed Forces veterans. We need to find out more.

#### The Building Safety Levy: Consultation

Deadline: 07/02/23

This consultation seeks views on the design and implementation of the Building Safety Levy. The Levy will be paid by developers and charged on new residential buildings requiring building control approval in England, for the purpose of meeting building safety expenditure.

The levy was announced in February 2021 and will ensure the taxpayer and leaseholders do not pay for the necessary remediation of building safety defects.

The consultation covers the following areas

- Overview and update
- Exclusions
- Supportive measures
- Impact on industry
- Sanctions and incentives
- Appeals
