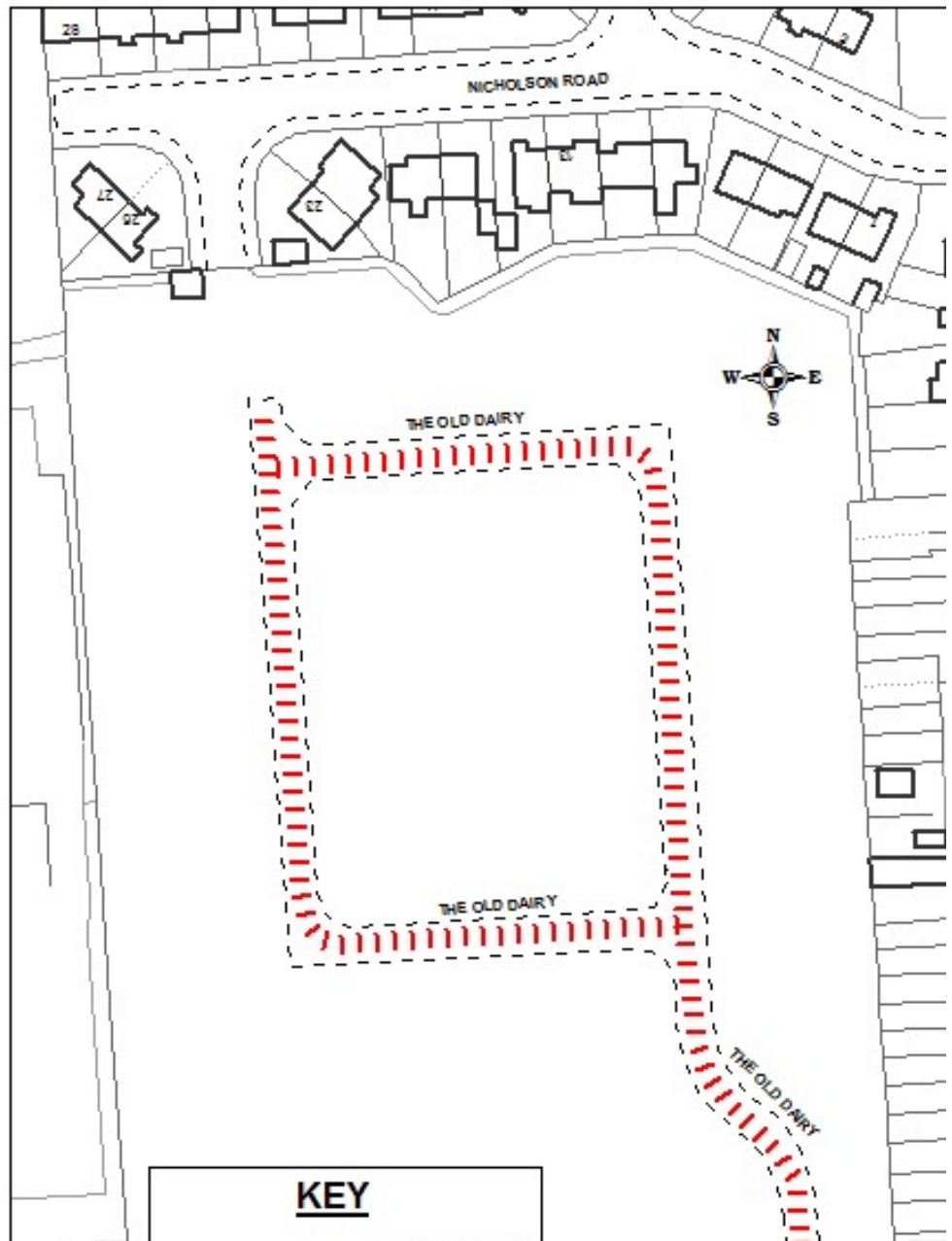

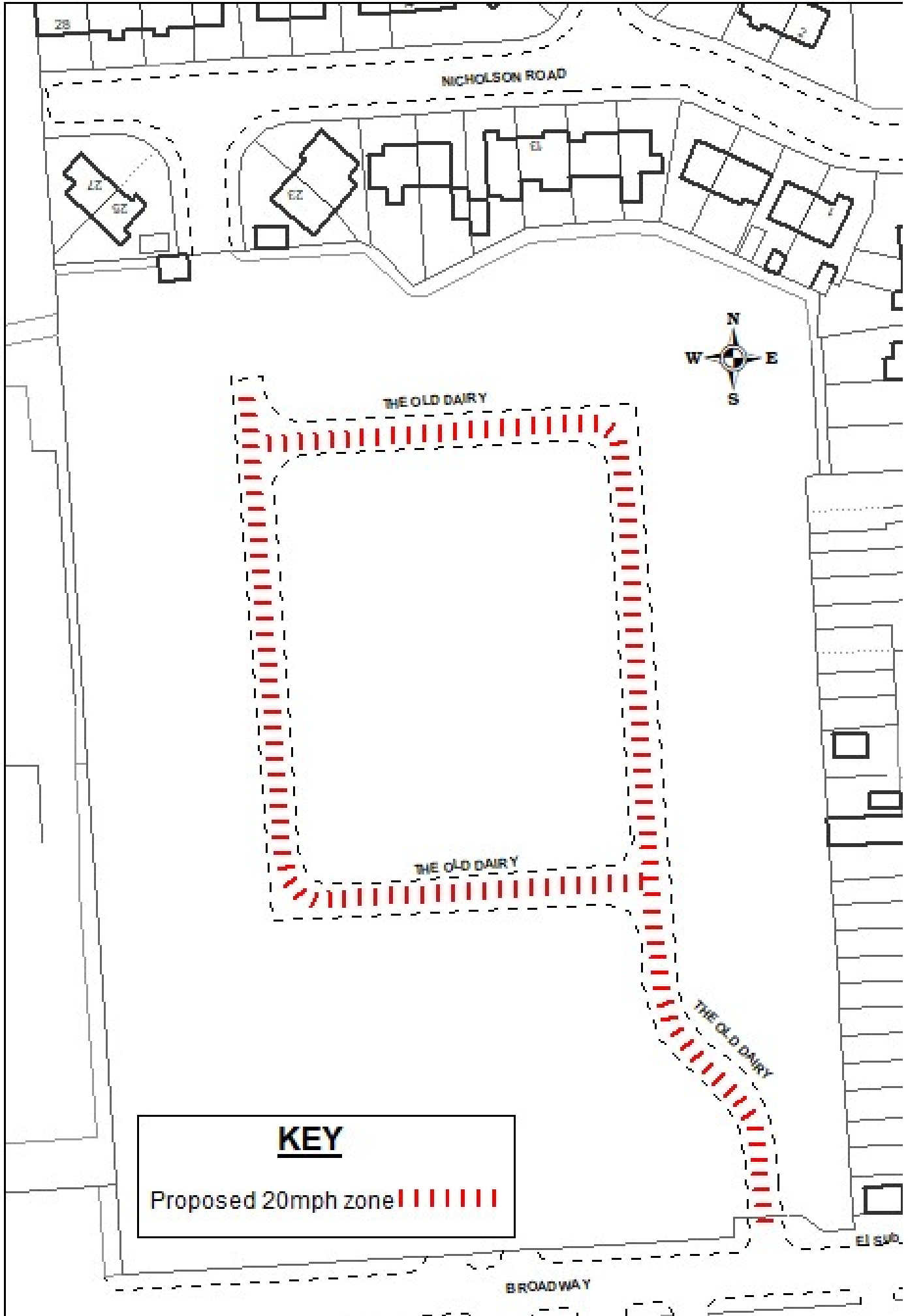

To introduce measures to meet the needs of the community and encourage slower vehicle speeds thereby enhancing road safety.



**ROAD TRAFFIC REGULATION ACT 1984**

**TAMESIDE METROPOLITAN BOROUGH COUNCIL  
(THE OLD DAIRY, HYDE)  
(20 MPH SPEED LIMIT) ORDER 2020**

The Tameside Metropolitan Borough Council, in exercise of their powers under section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984, and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act, hereby make the following Order:-

1. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the lengths of roads specified in the Schedule to this Order.
2. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment.

This Order will come into operation on <><> day of <><><> 2020 and may be cited as "TAMESIDE METROPOLITAN BOROUGH COUNCIL (THE OLD DAIRY, HYDE) (20 MPH SPEED LIMIT) ORDER 2020".
