	Discussion followed including if it was appropriate to ask Job Centre+ for rep for the group or at least further information for the website, for example on Youth Employment Scheme and ESF routes. CM to contact
	Discussion followed on the difficulties of finding appropriate provision for young people with challenging behaviour; mental health issues and young offenders. This group of young people may have EHCPs or they may have been supported at School support. It was felt that a case conference approach may work for exceptional cases where a mix and match approach to provision was needed to meet a young person's needs. AD mentioned that Oldham have an out of education process for NEET young people. DW reported that SENDIASS had had an increase of calls from parents of young people who had developed with mental health problems and so did not necessarily have or need an EHCP and they were experiencing difficulty accessing post 16 provision. The dilemma of assessing needs when the young people are not in education was discussed. All agreed that there was a need for skilled staff to support young people with mental health issues and the environmental changes between schools are large colleges also need to be considered. The need for appropriate risk assessments was discussed. SF informed the group that Tameside College were developing a new fitness to study policy.
	The group agreed that a protocol similar to the Fair Access Protocol in schools would help to address this issue. CM to convene a small working group to include AD, SF, WM and SH to look at drafting a Protocol for the next meeting.
	There was also discussion about transition for some learners out of education and how we can make it happen effectively. Need to involve Adult Social Care but the new Transition Social Worker when in post should help to fill some of this gap.
	DEVELOPING THE ACTION PLAN
	The draft action plan was discussed. Actions from today's meeting would be added.
	Discussions today would suggest that there is a need for an action around workforce development and sharing training within group members.
