Commodity list – Open Market

(guidance for stall allocations)

One trading area per registered commodity

Babywear

Clothing for babies up to the age of three, footwear and special occasion accessories i.e. christening/confirmation, wedding attire can be sold under this registration.

Bags & Luggage

Ladies and Gents bags of all types, including luggage, shopping trollies and holdalls. Wallets and purses of all types can also be sold under this registration.

Bakery Goods

Bread, muffins, cakes, including scones, flapjacks and potato cakes can be sold under this registration.

Bedding, Towels & Curtains

Includes the sale of pillows, cushions, pet beds, throws and curtain accessories.

Cards & Stationary

Cards for all occasions, wrapping paper and all stationary items can be sold under this registration.

Children's Fashion

All items of children's clothing, male and female. Children's footwear and limited accessories can be sold under this registration.

Cosmetics, Jewellery & Fashion Accessories

Make-up, beauty products & treatments, sun glasses, belts, all jewellery including watches and a gold exchange operation (cash 4 gold) are all covered under this registration.

Electrical Items – covers all small & large electrical items including vacuum cleaners and vacuum accessories and lighting.

Fabric & Material

All rolled fabric & material.

Floor Coverings

Carpets, rugs, laminate flooring and floor tiles can all be sold under this registration.

Footwear

Covers all footwear, ladies, gents' and children's.

Gent's Fashion

All items of men's clothing including coats. Footwear, sportswear and fashion accessories not included within this registration.

Haberdashery

Wool, and small articles for sewing, such as buttons, ribbons, zips, as well as craft books limited to fabric and wool design.

Hot & Cold Food

All hot and cold food (including fruit & veg) as well as hot and cold drinks can be sold under this registration. Pre-approval must be obtained from the Market Manager (traders are advised to write to us with an expression of interest) any changes or additions to the original registration must also have pre-approval from the Market Manager.

Household Goods, Kitchenware (non-electrical) & Toiletries

Cleaning products & accessories including mops/ mop buckets, brushes, and toiletries including toilet/kitchen roll, Ironing boards & maidens, pots, pans, general kitchen equipment, and dried flowers (including artificial Christmas trees & wreaths) can be sold under this registration.

Ladies Fashion

All items of ladies clothing including coats. Footwear, sportswear and fashion accessories are **not** included within this registration.

Mobile Phone & Smoking Accessories

Cigarette papers & filters, E-cigarettes (including chargers & refills), traditional pipes, batteries and watch batteries, mobile phone & tablet cases, chargers and hands free kits can also be sold under this commodity group.

Outerwear

All coats, and mountaineering equipment including water proofs, rucksacks and walking boots can be sold under this registration.

Pictures, Frames & Mirrors

All shapes and sizes.

Plants/Flowers and Garden Accessories

All plants/flowers and garden ornaments including the sale of Christmas wreaths and trees can be sold under this registration as well as items used for gardening including forks, spades, garden trowel etc. **Dried or artificial goods cannot be sold, including dried flowers and artificial Christmas trees and wreaths.**

Second Hand/Used Goods (Tuesday & Sunday only at Ashton, Monday at Hyde)

A second-hand or used good is one that is being purchased by or otherwise transferred to a second or later end user. A used good can also simply mean it is no longer in the same condition as it was when transferred to the current owner.

Sportswear & Equipment

Branded sportswear for ladies, gents and children can be sold under this registration. This includes footwear but not jeans. Includes fishing equipment (not fresh bait).

Sweets & Confectionary

Sweets, chocolate, chocolate bars, biscuits, cold drinks and crisps can be sold under this registration. **Not cakes.**

Toys & Gadgets

Full range of children's toys, jigsaws, and gadgets associated with the toy industry.

Underwear, Socks & Hats

Includes lingerie, tights, gloves and scarfs.
